FEES and DUES

Enrollment Fee: To establish a membership, member agrees to pay a one-time enrollment fee of \$25.00. Enrollment fee is non-refundable.

Monthly dues for the membership are have been selected by member and will be due every 30 days from the enrollment date. Monthly dues will be collected electronically every 30 days from the enrollment date, unless previously paid by other means. The Studio by Innutra accepts the following forms of payment: AMEX, Mastercard, Visa, Discover and Electronic Funds Transfers from a checking account. All memberships are month-to-month and may be cancelled at any time with 30 days notice. In the event cancellation occurs prior to the expiration of a paid month, The Studio by Innutra is not required to refund and portion of the month to member.

SUSPENSION/TERMINATION OF MEMBERSHIP BY MANAGEMENT. Management has the right to suspend and/or terminate membership for non-payment of dues or for behavior inimical to the enjoyment of The Studio by Innutra by other members and staff for any reason deemed sufficient in the sole discretion of The Studio by Innutra and its management.

BUYER'S RIGHT TO CANCEL OR TERMINATE. Members have the right to cancel this agreement within three (3) business days after acknowledgement of this agreement.

Cancellation must be in writing and delivered via email to mail.innutra.com. In the event of a three (3) day cancellation, The Studio by Innutra will refund all enrollment fees and dues paid. The Studio by Innutra's enrollment fees are non-refundable except as indicated above.

MEMBER'S HEALTH WARRANTY.

The member acknowledges and agrees that: 1) The Studio by Innutra will rely on the foregoing warranty in issuing the membership; 2) The Studio by Innutra shall have no obligation to perform a fitness assessment or similar testing to determine the member's physical condition; 3) if any fitness assessment or similar testing is performed by The Studio by Innutra, it is solely for the purpose of providing comparative data with which the member can track progress in a program and is not for diagnosis purposes; 4) The Studio by Innutra shall not be subject to any claim, demand, or injury whatsoever on account of The Studio by Innutra's evaluation or interpretation of such fitness assessment or similar testing; and 5) The Studio by Innutra shall not be liable for any injury arising out of the member's disability, impairment, or ailment preventing him/her from engaging in active or passive exercise, or that would be detrimental or adverse to such person's health, safety or physical condition if he/she does so engage or participate. Each member and guest should be aware of his/her medical history and should consult with a physician prior to engaging in exercise or continuing to exercise if a medical condition appears or appears to be developing.
